Admin Parking Lot Scope of Work

- Asphalt peel-out and replacement.
- Excavate and dispose of existing asphalt, 2"-3" thick.
- Grade and compact existing stone.
- Apply vegetation killer where necessary.
- Install 8' x 8' concrete around (2) exiting catch basins.
- Install new commercial grade asphalt to 3" thickness or as needed.
- Roll and tamp edges.
- Apply existing style striping and handicap marking.
